

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.hotyogahilo.com, and Hot Yoga Hilo, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Hot Yoga Hilo, LLC include www.hotyogahilo.com and HYH, LLC. The HYH, LLC website is a Information, class bookings, pass purchases site. By using the HYH, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, HYH, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase HYH, LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

HYH, LLC may also collect anonymous demographic information, which is not unique to you, such as your:

Sharing Information with Third Parties

HYH, LLC does not sell, rent or lease its customer lists to third parties.

HYH, LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. HYH, LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. - Comply with the California Electronic Communications Privacy Act;
